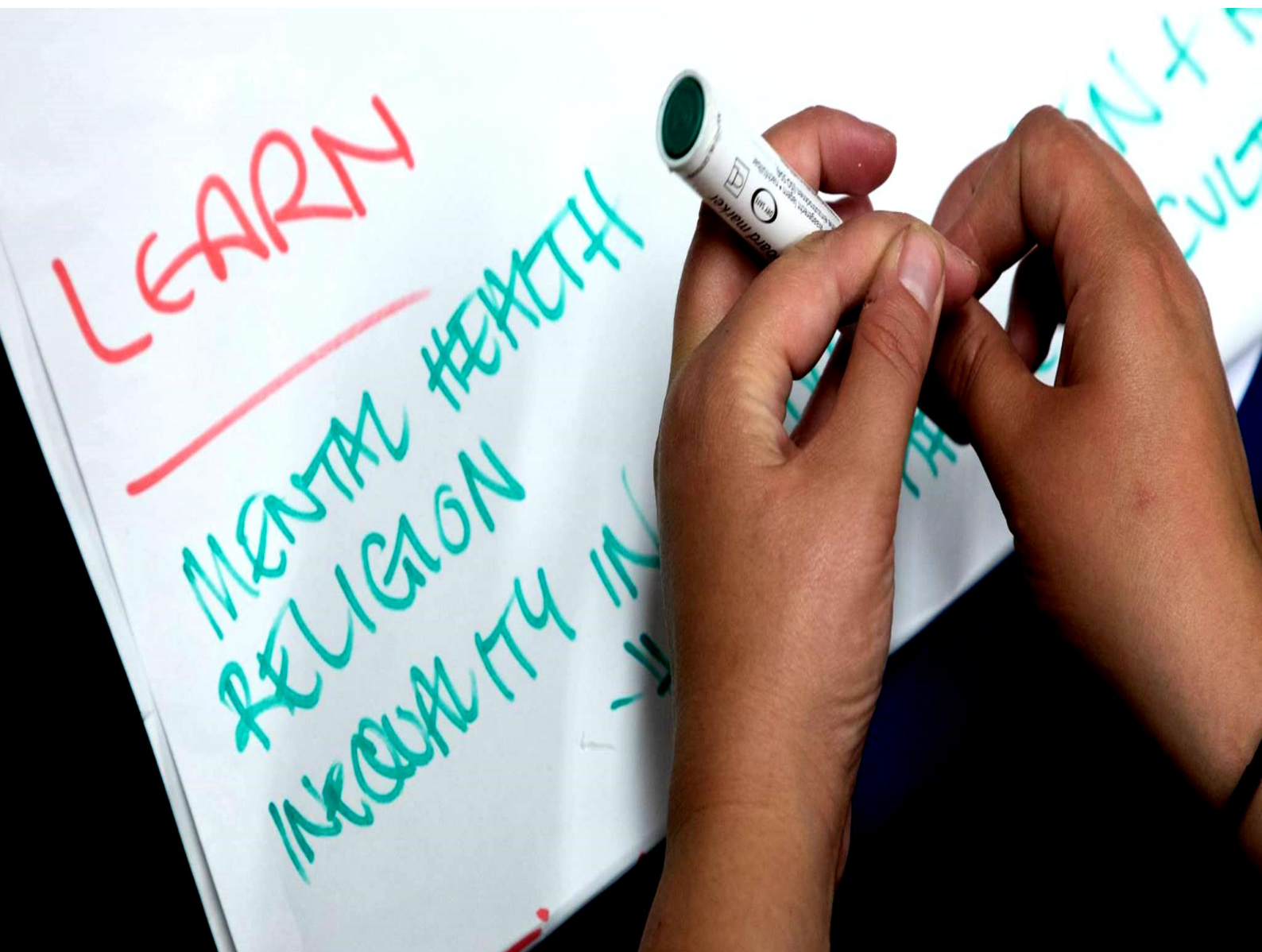

Chief Executive Officer's Report

I am delighted to be able to reflect on what has been a very successful year for VAS, during which we have made further progress in ensuring a sustainable future for the organisation - against a very difficult funding backdrop for the voluntary and community sector, locally and nationally. We have also continued to make a positive difference to the many groups and organisations we support.

In last year's report, I mentioned that we had worked hard to balance our budget following several years of losses (indeed I note that, before last year, the last time VAS generated any surplus was in 2008/9). We have continued our prudent approach to financial management this year, with the result that we have delivered a surplus of nearly £25,000. We are now making use of this surplus in a balanced way to:

- Ensure our reserves do not become depleted
- Invest in VAS to ensure we continue to improve the delivery of our charitable objects. A good example is that we have increased the working hours for the Development Officer role which focuses on equality and inclusion
- Carry out some much needed maintenance work at John Street, including repairs to the roof and new carpets on the top floor

We have also been able to reinvest money into Sanford House (on e.g. improved signage, additional seating areas, improved kitchen facilities), for the benefit of both the tenant organisations and service users.

Most importantly, we continue to deliver real value to a wide range of groups and organisations – as described elsewhere in this report.



Looking forward, we have much to do in 2018/19, including:

- Bidding for a new voluntary and community sector support contract from SBC (the existing contract, currently in an extension period, is due to end in December 2018)
- Progressing the project to renovate the former caretaker's cottage next to Sanford House (which we intend to use to provide supported accommodation)
- Representing the sector at a range of boards/forums and initiatives. A current exciting example is the formation of a community interest group which will be formally launched towards the end of the year and which will seek to promote and develop social enterprise in the town

In summary, I think we can take great pride in a team effort which has led to a very positive year. My thanks go to the VAS staff and volunteers (including, of course, our trustees), our members, funders and our many other friends and supporters.

Training Courses at VAS

VAS offers a range of training courses for the local voluntary and community sector, including Fire Safety, First Aid at Work, Food Safety, Health & Safety, Life Support, Lone Working, and Manual Handling. Last year, we ran 28 courses attended by 211 people from the local voluntary sector.

Our training courses are aimed at the local voluntary sector, and are therefore heavily subsidized (typical course prices are £45 for a half day course, £95 for a full day course).

Some of our most popular courses include:



First Aid at Work

Make sure you are able to respond confidently to a range of first aid incidents and emergencies. This course will teach you the skills and knowledge to give emergency first aid in a low-risk work environment.



Fire Safety

Learn essential knowledge about fire safety, including carry out a fire safety risk assessment, implement appropriate fire precautionary and protection measures and maintain a fire management plan.



Health & Safety

All employers are required to have the correct systems in place to ensure a healthy and safe working environment for employees and any other people who may be affected by their business activities.

Swindon Sports Forum



Swindon Sports Forum is the voice of the sporting community in Swindon. VAS supports the Sports Forum's administration, enabling it to bring funding into the town to help develop local sports clubs and to hold regular club training and development courses. The Forum is run by a committee of dedicated volunteers who work with partners including Wiltshire & Swindon Sport (WASP) and Swindon Borough Council.

VAS's administrative support has enabled Swindon Sports Forum to focus on delivering its objectives, including awarding £14,000 worth of funding to 13 local sports clubs, including £600 to two young people from deprived areas of Swindon, which will allow them to take part in sports.

VAS supported the Sports Forum to form a working partnership with Total Swindon, and to run two public events which provided local sports clubs with information about funding opportunities. We helped to produce the Sports Forum's monthly newsletter, which passed on information to sports clubs such as the availability of bike racks in the town.

Sector Support

Some of our achievements in the last year:



Supported Inner Flame to raise £45,000 from the Blagrave Trust; Swindon Children's Scrapstore to raise £23,000 from the Aviva Community Fund; and Headway Swindon to raise £10,000 from Wiltshire Community Foundation.



Supported more than 100 local organisations with funding and governance advice, including helping Sabrina's Mile, Swindon City of Sanctuary, STEP and Oak & Furrows to register as charities or change their legal structure.



Held 2 Equality Ambassador events to engage people to drive forward the Swindon200 project, launched the Swindon200 monthly radio show, and supported Refugee Week, with events attended by over 500 people.



Organised training for 40 local organisations on charity law, new fundraising rules, taxation and trade for charities, charity reserves, workplace pensions auto-enrolment, cyber crime, fraud, and new data protection rules (GDPR).
